



Existing signs in this approximate location to be removed and replaced with crossroads ahead sign to Diagram 504.1 and 'HEAVY PLANT CROSSING' message plate to Diagram 511. New signs to be positioned in accordance with guidance given in appendix A of Chapter 4 of the Traffic Signs Manual.

Flat top speed hump to be provided (8m long, 75mm upstand and 1:13 ramp gradient). Need to amend / renew existing speed hump on approach subject to further investigation.

All existing bollards at the junction to be removed and a single milestone or similar to be placed in each quadrant of junction to prevent HGVs from turning onto / off the public highway.

'GIVE WAY' sign to Diagram 602 to be provided and existing stop sign on this approach to be removed

Replenish existing give-way marking to Diagram 1003

Replenish give-way triangle to Diagram 1023

'GIVE WAY' sign to Diagram 602 to be provided and existing stop sign on this approach to be removed
